Autumn Half Term

Next week marks the end of our first half term back at Nursery. We will be finishing at the usual time on Friday and will be back from Monday 2nd November. We are so grateful for all the support since returning to nursery. It has been a been a busy few months ensuring we are Covid compliant and because of the additional cost of cleaning materials and resources we are no longer able to reuse (playdough etc) we are having to add a small additional cost to the invoice to cover this. At the beginning of term we shared the nursery's risk assessment so that you could see the measures the nursery is taking to keep everyone safe. I would like to take this opportunity to extend my thanks to the whole staff team who are all going over and above at the moment. At a time when large numbers of the population are being asked to work from home to keep safe, the team are coming in every day, keeping positive and making sure the children are having the best possible experience. Day to day tasks and routines that we wouldn't normally have to consider are constantly having to be re-thought to factor in hand washing and additional safety measures. We are asking staff to clean the nursery, toilets and cloakrooms throughout the day. Of course this is our job as Early Years Teachers and we feel privileged to be in this wonderful profession, but I think it is important for you all to be aware of the additional strain this is putting on all education settings and would ask you maybe give the teachers a little extra smile in the mornings. We will always respond to your queries but it might take a little longer at the moment. Please do also make use of the resources on the website and or Tapestry as a lot of information can be found on there. We will be updating the risk assessment over half term in line with staff discussions and government changes and ask that parents check this if you are interested. The website contains a vast amount of information on the nursery. We ensure that all policies and information are available on here for parents to access. Please check here first if you have any questions about the nursery systems, fees or policies. If you are unable to find the information you need then of course speak to the teachers.

Pick Up

We are changing our pick up times at the end of the day to support those of you that do school pickups. If you would prefer to pick up at 2.40 so you can get to school on time then please let the staff know. We ask that parents either pick 2.40pm or 3pm and stick to these times. These are the only times at the end of the day we will be dismissing the afternoon children from now on

All items (including clothes) are clearly labelled.

Water bottles should only contain water. Please no juice or squash. Children have the choice of milk and water at lunch time.

Please could we have any donations of tissues and baby wipes. As you can imagine going into cold season we are using these a lot.

As the weather starts to change we will still aim to be outside as much as possible. Therefore please can you ensure your child has a named coat, hat and gloves when necessary.

We have now started the teacher supervision meetings. This is an opportunity for staff to discuss their personal targets and areas they would like to work on for their own continuous professional development.

We have been extremely impressed with all staff during these meetings. It is clear the teachers are extremely passionate about their work with the children and are dedicated to ensuring both they and the nursery are the best they can be.

So far our focus for staff at Lightwater this year is to continue developing Forest School activities, ensuring all children have regular access to the forest throughout the week and continuing our work on Phase 1 phonics. Laura will be working with the Lightwater team on these areas. Meetings will continue with Lightwater staff after half term and we will also start working with the Staines team. These meetings form the basis for our nursery development plans and training opportunities.
